## Saturday, October 12, 2024 from 9:00 am to 4:00 pm

The Blount-Oneonta Chamber of Commerce is making plans for our 40th Annual Covered Bridge Festival. This year's festival will be Saturday, October 12, 2024, in historic downtown Oneonta from 9am to 4pm. Many activities take place throughout Oneonta and Blount County during the Covered Bridge Festival, with as many as 10,000 people visiting throughout the day. We work diligently planning new events that are sure to draw even more!

The Chamber is now accepting applications. To reserve your booth space, please fill out the attached form. Please send in your completed form, along with your booth registration fee, to Blount-Oneonta Chamber of Commerce, 110 1st Avenue East, Oneonta, AL 35121. Registration deadline is 4pm Friday, September 27, 2024.

Within two weeks of the festival, you will receive an email or a letter detailing your booth number and additional setup information for the festival.

Booth Rules & Information

- Booth set up time is from 6:30am to 8:30am on Saturday, October 12th. No vehicles will be allowed into the festival area after 8:30am. Please unload items and place in your designated spot, move your vehicle, then return to set up.
- Vendors must enter the festival area from Highway 75 at 3rd Street. Chamber representatives will be there to check you in and assist you in finding your booth location.
- Vendors must furnish any tables, chairs or coverings needed for their booth.
- Booth areas are paved. No tent stakes can be driven into the ground.
- Utility service is not provided. **Quiet** generators are allowed, but must be approved before the event. If you plan to use a generator, indicate the year, make and model on your application. **No loud generators allowed!!!**
- Payment must be submitted with registration. Deadline for registration is Friday, September 27. If space is available after the deadline, we will accept late entries.
- The Blount-Oneonta Chamber of Commerce reserves the right to reject booth applications from vendors that are not in line with the family-friendly nature of this event.
- All food vendors must provide a certificate of insurance showing coverage of \$1 million. The Blount-Oneonta Chamber of Commerce must be added as an additional insured (this is a requirement of our insurance carrier).
- Vendors must list all items you plan to sell. This helps in determining booth position.
- Vendors must not block the door of a business.
- Vendors cannot place items on the sidewalks.
- Vendors must remain in place until close of the event at 4pm.
- Vendors are responsible for complete clean up of their space. All trash must be placed in cans.
- The Covered Bridge Festival is a rain or shine event.
- Vendors will not be allowed to sell or give away live animals at the Covered Bridge Festival.
- If rules are not followed, a vendor's participation may be terminated at any time during the event; and their booth registration fee will not be refunded. If a vendor does not follow festival rules, they may not be able to participate in future events.
- Booth location preference will be given to Chamber members. Contact us for more information on joining!
